


Today, the IAU brings together over 600 Members from more than 120 countries. # Message from the Secretary-General



Welcome to the IAU 2024 Annual Report, which examines the period of 1 October 2023 to 30 September 2024. This academic and financial year began with the IAU 2023 International Conference at Qatar University in Doha where we discussed Higher Education with Impact - the Importance of Intercultural Learning and Dialogue. The success of the Conference, which welcomed over 300 participants from 80+ countries, set the stage for the year to follow. Amid heightened geopolitical tensions and pressures on universities, the Conference reaffirmed the IAU community's commitment to global citizenship, peace, respect for diversity, and the belief in the power of higher education to transform society for the better.

Beyond the annual Conference, this year has also been marked by many achievements and progress on various fronts of IAU work, in particular for our four priority areas: Leadership, Internationalization, Sustainable Development, and Digital Transformation. Work has excelled this year thanks to support from the priority area working groups established by the Administrative Board in 2023. They have helped inform the IAU Executive Leadership Programme; the 2nd IAU Global Survey on Digital Transformation; a Report on Open Science: The Challenge for Universities; the IAU Cluster for Higher Education and Research for Sustainable Development (HESD); the presentations of the IAU 6th Global Survey Results; and the reimagined IAU Internationalization advisory programme, now known as HEIAS. Each of these programmes provides long-term benefits for institutions and individuals involved. The priority areas also inform our ongoing Webinar Series on the Future of Higher Education. Thus

far, the series has produced over 70 webinars. Beyond offering an opportunity for participants to learn from, we invite Member institutions to use the series as a basis for internal and further debate.

In addition, this year has also witnessed the continued development of the *IAU World Higher Education Database* (WHED). This March, the WHED team finished an update of 2500 HEIs in the United States, and has begun to review institutions and systems in the African continent. The WHED remains the only official source of information on HEIs and HE systems at the global level; it is a critical resource in the context of the *UNESCO Global Convention on the Recognition of Qualifications concerning Higher Education*.

As well, the IAU has participated in some 30 events around the world, either in person or virtually. We co-organised some of the events, contributed sessions to others and delivered keynote speeches where we advocated for the importance of high quality, open and accessible higher education for society. This strong engagement led to strengthened cooperation with UNESCO, the UN, global partners, and, of course, our Member institutions and organisations. It is thanks to this deep engagement with and of our Members and the shared belief in the power of higher education that we are able to pursue our mission as the global voice of higher education.

I invite you to discover more about the work of the Association by reading through this report, as well as to become more involved in our various programmes and events. Additionally, if your institution is not already a Member of the IAU, I encourage you to consider joining our global higher education community.

# **GOVERNANCE**

The IAU Administrative Board convened its 93<sup>rd</sup> meeting at the IAU 2023 International Conference hosted by Qatar University.

Andrew Deeks, IAU President 2022-2026, inaugurated the meeting by stressing the successful organisation of the Doha conference. The Conference sessions welcomed many excellent speakers and triggered high-level conversations on *Higher Education with Impact: The Importance of Intercultural Learning and Dialogue*. The focus on Open Science during the International Conference was welcomed, and it was highlighted that Digital Transformation, Open Science, and Generative AI are important topics to be addressed by the IAU.

President Deeks moreover acknowledged the work of the Secretariat on the Association's four priority areas. With regard to expanding the IAU's reach, the President pointed out that the IAU Secretariat must more proactively engage with partners worldwide to ensure more inclusivity and diversity in the IAU's collaborations. President Deeks thus proposed to continue conversations around key themes and issues addressed in the meetings, including the positioning of the IAU vis-a-vis rankings, multilingualism, and IAU membership development. In particular, the Board welcomed the Secretariat's use of the Working Groups and Expert Groups established to guide the work of the Association.

At the meeting, the Administrative Board accepted the invitation from the University of Rwanda to host the IAU 2025 International Conference.

# A Standard and Trendsetter

This commitment allows the IAU to accurately represent the diverse higher education community, contribute to informed policymaking, provide recommendations, and advocate for strong, accessible, and equitable higher education systems globally. As a standard and trendsetter, the IAU develops Policy Statements on issues of global concern for higher education.



# A Facilitator for International Collaboration

The IAU organises global events and webinars with speakers and participants

from all regions around the world. These initiatives foster mutual exchange and dialogue across the IAU's four thematic priority areas to promote collaboration, networking, and the establishment of strategic partnerships.



# A Capacity Builder

The IAU offers capacity-building and advisory services to support institutional development at every

stage, such as the Internationalization Strategies Advisory Service (ISAS2.0), which supports higher education institutions in developing, reviewing, and enhancing their internationalization strategies; IAU's Executive Leadership Programme (ELP), which provides current and emerging university leaders with the tools and networks their universities need for success; Responsible Futures International (RFI), which aims to embed holistic sustainability in student learning at educational institutions and brings sustainability at the heart of education; and institutional site visits on the digital transformation of HE, that connects universities globally for exchange on innovations related to digital transformation, including teaching & learning, and research. Members are invited to engage with these programmes.



# A Think Tank and Knowledge Hub

The IAU conducts research and global surveys on the higher education sector

and on institution specific issues. The Association further ensures the dissemination of relevant knowledge and data in relation to its strategic priorities, as well as information relevant to current events and ongoing sectoral debates. IAU Members are encouraged to take part in global surveys and research opportunities to help inform the global higher education community of regional, national, and international trends.



# A Centre for Communications

The IAU disseminates information and news relevant to the broad higher education community around the

world, including universities and other higher education institutions, as well as national and multilateral organisations and government agencies. Members are invited to follow the IAU on social media, sign up for the IAU monthly newsletter, and share information with the IAU so that it may be disseminated amongst the Membership community.

# **GLOBAL EVENTS**

# IAU International Conference 2023

The IAU 2023 International Conference welcomed more than 300 participants from around the world to Qatar University in Doha to discuss "Higher Education with Impact: The Importance of Intercultural Learning and Dialogue." The meeting highlighted a crucial need for higher education institutions around the world to mutually and strategically develop alliances to foster common understanding and collaboration.

The conference emphasised the critical role of the universities as hubs for fostering intercultural learning and competence. During the conference, it was emphasised that the higher education sector has the responsibility to support and cultivate intercultural learning and dialogue not only at institutions but throughout society. This duty lays the foundation for higher education institutions around the world to acknowledge and embrace cultural diversity and provide students with an environment to thrive.

During the opening plenary session entitled "The Intercultural Imperative in a De-Globalizing World?" speakers highlighted that universities are inherently intercultural: in their mission and daily activities. This key characteristic and principle must remain inviolable, even in times of strife and heightened geopolitical tensions as universities are essential in building intercultural competencies, nurturing mutual understanding, and establishing a sense of interconnectedness. In a world that seems increasingly polarised and divided, marked by the erosion of social coherence and human freedoms, universities can leverage their influence and stem breakdowns in civic discourse.

During Plenary Session III on "The Impact of Geopolitics on the Future of International Cooperation," panellists discussed the pressing dilemmas higher education leaders face and their impact on universities and global collaboration in a world grappling with escalating geopolitical challenges. The conflict in the Middle East served as a poignant example, highlighting the complexity and heterodoxy universities need to navigate. While universities embrace diverse perspectives, it was emphasised that war 'embodies' the ultimate divergence of opinions. This raises an important question about the role of universities and how leaders must mitigate the extraordinary geopolitical pressures by their various stakeholders and constituents during times of conflict. Criticism has been levelled against universities for taking a public stance, while others face criticism for lack of it. On top of the responsibilities of upholding institutional integrity and credibility, universities must avoid being 'instrumentalized' by political and social actors. One speaker translated this dilemma into a discourse of







academic responsibility: university leadership must choose to take or abstain from a public stance and defend their decision clearly. The ability of university leaders to take a stance further hinges on the contextual situation and the systems within which their institutions operate. It emerged that striking a delicate balance between upholding university values and preventing political interference has become increasingly challenging in many parts of the world.

Overall, the discussions reinforced the importance of the truly global platform IAU provides for voices around the world to convene and share their perspectives on the evolving challenges and opportunities that the higher education sector faces. To close the conference, IAU Secretary General Hilligje van't Land stressed that intercultural learning not only enriches the academic experience but also nurtures responsible global citizens capable of positive change. Moreover, she reiterated the key role of higher education institutions in society today, as they are crucial for fostering intercultural learning and dialogue, an essential aspect of their social mission and promoting a culture of peace.

# IAU Representation at Events

This past year, the IAU was honoured to strategically engage and speak at various events and conferences around the world. The IAU had the privilege to co-host many of these events in collaboration with its partners and Members. Others were hosted by the United Nations and its bodies with whom the IAU works closely to shape the future of higher education. The IAU's presence at this year's events reinforces the Association's commitment to engaging in activities and discussions that benefit the higher education sector at large and around the globe. # Transforming Knowledge for Africa's Future UNITWIN Forum

30 September-2 October 2024, Addis Ababa, Ethiopia

IAU was an official partner to the *UNESCO Chairs and Partners Forum* in Addis Ababa, which aimed to strengthen interdisciplinary and collaborative research capacity in Africa, through more inclusive and effective South-South and South-South-North research partnerships. The IAU Board Members from Tunisia, Ghana, Zimbabwe, Nigeria and Ethiopia, IAU Members and partners and the IAU Secretary General were invited to speak in several Forum sessions and hosted an engaging debate on *"Stronger Higher Education and Doctoral Education for a Stronger African Continent"*.



# UN High-Level Political Forum (HLPF)

16 July 2024, New York, USA

# THEMATIC PRIORITIES



Strengthening capacities of leaders to maximise positive impact of universities.

Leadership, as a core aspect of quality higher education, is vital for enabling institutions to respond to complex challenges successfully and to bring about social transformation. Higher education leadership must be underpinned by values and responsibility; it must also constantly evolve in order to address emerging challenges and opportunities. The IAU priority on Value-based and Globally Engaged Leadership aims to foster exchange of ideas and experience and offer capacity building opportunities for university leaders.

IAU endeavours to strengthen the capacities of university leaders and enhance cooperation among HEIs across the world. Thought leadership for university leaders as part of a truly global discourse is what the IAU offers its members at its conferences, webinars, and in publications. It fosters exchange on the most pressing issues of concern to higher education. Moreover, capacity-building for university leaders is central to the IAU's work, one such example is the IAU Executive Leadership Programme (ELP).

# **Leadership Working Group**

This year, the Leadership Working Group met three times to discuss the general direction of the priority area and focused in particular on three areas: the design of the IAU Executive Leadership Programme (ELP), the development of the IAU President's Forum at the IAU 2024 International Conference, a discussion on how the IAU could offer additional support and exchange between university leaders throughout the year, and whether to include aspects of university governance in the priority. The Secretariat wishes to extend its thanks to all members of the working group, and in particular to Patrick Deane, IAU Vice President and Chair of the Leadership Working Group.

# **Executive Leadership Programme**

The IAU 2023 International Conference in Doha marked the launch of the first edition of the IAU Executive Leadership Programme (ELP). The ELP had set itself the ambitious task to be radically global in its ambition to support university leaders across all higher education systems and types. Its intention is to empower university leaders to manage their institutions successfully and sustainably while navigating the contextual, ethical and political dimensions of university leadership. Guided by experienced current and former university presidents and other practitioners, the programme provides a framework with which to confront the big managerial, ethical, economic and societal questions universities face. Part of the attraction of the programme has been the lively peer-to-peer exchange and

learning between the 14 institutions in Africa, Asia and the Pacific, the Americas, the Middle East and North Africa, and Europe. This created unsuspected synergies, collaborations and new insights and demonstrated that a global capacity-building programme for university leaders can successfully straddle different higher education systems if the design of the programme is tailored around principles and best practices.

The first edition of the programme consisted of 10 modules taking place in person in Doha, online throughout the year, and concluded in Tokyo at the IAU 2024 International Conference upon presenting their capstone projects.

This first year of the programme has served as not only a learning experience for participants, but for the IAU as well. Planning for the second edition of the programme also began in early 2024. Intermittent review of the course and constructive consultations with the Leadership Working Group and the Administrative Board have led to slight changes to the programme format and content, including the introduction of two new modules on *Shaping Higher Education in an Increasingly Digital World and Forming Transformative Partnerships with Students* and restructuring the Action Learning Groups which accompany each module. The next edition of the programme will begin with three in person sessions in Tokyo at the 2024 International Conference.

**Advocacy** and thought leadership stand as a cornerstones of the IAU's commitment to quality higher education for the global common good, and they are embedded in the Association's mission to guide leaders of universities and other higher education institutions (HEI) worldwide.

Advocacy and thought leadership extend into all priority areas of work of the Association. Through joint projects, research endeavors and global collaborations, the IAU fosters a culture that promotes ethical principles, social responsibility and cultural diversity in academia.

By championing values such as inclusivity, integrity, and equity, the IAU inspires a global community of leaders, educators and administrators to embrace these ideals in their own institutions. In 2024, IAU advocacy efforts were particularly visible in our engagement with global events (page 10), as well as with regional and thematic ones.

In particular, meetings between members of the IAU Leadership team and government representatives from around the world provided excellent grounds for the Association to advocate for the right to and necessity of values based higher education. This work will be continued in the future.

# **Internationalization Working Group**

The Internationalization Working Group held two online meetings on 17 June 2024 and 10 September 2024 which were devoted to the finalisation of the new programme of advisory services in internationalization, following the Administrative Board decision at the IAU 2023 International Conference in Doha. The new programme: Higher Education Internationalization Advisory Services - HEIAS will be launched first in the IAU newsletter of November 2024 and then at the IAU International conference in Tokyo, 22 - 24 September 2024.

Sixth edition of the Global Survey on Internationalization of Higher Education

On 2 April 2024, the report of the  $6^{th}$  edition of the Global Survey on the Internationalization of Higher Education was published and officially launched through a webinar. The survey was a collaborative effort between the IAU and partner organisations. The full list of supporting organisations is available on the IAU website.

The survey collected 722 unique replies from higher education Institutions in 110 countries and territories around the world. The data was analysed at both global and regional levels, and the results were summarised in a full report, an executive summary and in figures. The full report and the executive summary have been translated into French thanks to the support of the *Agence Universitaire de la Francophonie* - AUF.

Results have been presented at various conferences and events, both online and in-person, in different regions of the world. Notably, two dedicated webinars were organised to present the results for Asia & Pacific and the Middle East and North Africa.

# **Partnerships for Internationalization**

# Network of International Education Associations (NIEA)

The Network of International Education Associations (NIEA), coordinated by the IAU, held two meetings in 2024 at the NAFSA and EAIE conferences in May and September 2024 respectively. Planning began in early 2024 for the third *Global Dialogue on Internationalization of Higher Education* to be held in South Africa, but the event was since cancelled as contributors continue to debate the advantages of an in person versus online event.



# Future of Internationalization Partnership (FIP) Project

The Future of Internationalization Partnership (FIP) is a threeyear project that began in May 2021. Funded by the Social Sciences and Humanities Research Council of Canada (SSHRC), the project brings together The Center for International Higher Education (CIHE) at Boston College, the Ontario Institute for Studies in Education (OISE) at the University of Toronto, and the IAU.

FIP aims to deepen theoretical understanding of how internationalization is changing in response to global pressures. During the third year, the project focused on conducting further analysis of select questions from the sixth edition of the IAU Global Survey on Internationalization, which address emerging issues on internationalization. The themes analysed included: international partnerships, the link between internationalization and sustainable development, and the link between internationalization and diversity, equity and inclusion. The project will end in 2025.

# COST Action - European Network on International Student Mobility: Connecting Research and Practice - ENIS

ENIS responds to the need for systematic interdisciplinary and international exchange of knowledge on theoretical frameworks, research methodologies, findings, and best practice examples, as well as translating scientific findings into recommendations for International Student Mobility - ISM practice. It does so by bringing together researchers in ISM from different academic fields as well as practitioners working at international offices at higher education institutions, national agencies and other governmental organisations, NGOs and student associations.

In 2024, Giorgio Marinoni, Manager HE and Internationalization and leader of the *ENIS Working Group 5: Connecting Research and Practice*, chaired a session at the ENIS annual conference in Tbilisi, 13 - 15 May. There, he presented some of the outcomes of the work of WG5. These outcomes include short articles published by practitioners in ISM in media, results of the needs analysis of researchers and practitioners, and exchange between researchers and practitioners. He also contributed to the thematic reviews conducted by WG1 on International Student Mobility, which is still ongoing and on the Impact of COVID-19 on Higher Education, which was submitted for publication in a special issue of "Comparative Migration Studies".

COST funding for the ENIS network will end in 2025 and the network is already discussing a sustainability plan for the future.

# Research project on Ukrainian students with refugee/migrant background at Higher Education Institutions in France

Thanks to the initiative of Kateryna Nakvatska, who was an IAU Internationalization intern between February and July

2024, the IAU began a research project on the experience of Ukrainian students with refugee/migrant background at Higher Education Institutions in France. This qualitative research project is a follow-up project to the 6<sup>th</sup> IAU Global Survey on Internationalization and it is a cooperation between IAU and a research group at the Middle East Technical University - METU in Ankara, Türkiye. 21 Ukrainian students were interviewed, and the results of such interviews were analysed with the intent of publication of a scientific article in a peer-reviewed academic journal.

# Online Diploma on the Management of Higher Education Internationalization

In collaboration with the UNESCO Chair for Internationalization of Higher Education and Global Citizenship of the University of Guadalajara, the IAU is organising the second edition of the online diploma on the Management of Higher Education Internationalization. This second edition expanded the focus of the first from Latin America and the Caribbean by including two new regions: Africa and the Middle East.

# Sustainable development

Strengthening the role of Higher Education for the UN Decade of Action for Sustainable Development and encouraging cooperation between HEIs.





Initiatives undertaken in the context of the IAU thematic priority Higher Education and Research for Sustainable Development (HESD) include the following:

**HESD Working Group** 

To achieve the goals set in the IAU Strategy 2030, the HESD actions are structured around key activities and communicating with the Membership and partners beyond. IAU HESD work is supported by experts from the IAU HESD Cluster and the HESD Working Group (WG). The WG chaired by Prof. Jouhaina Gherib met on 6 October and 6 November 2023 and approved the Cluster Terms of Reference (see above) during this meeting. The second meeting took place on 6 June 2024.

# IAU HESD Cluster: fostering peer-to-peer learning

Initiated in early 2018, the <u>IAU Global Cluster on HESD</u> brings together around 70 universities around the globe, including 16 'Leads' coordinating the work per SDG. The IAU leads on SDG 17: Partnerships for the goals. In the past year, two main IAU HESD Cluster Meetings took place virtually on 25 and 26 March, and on 27 September 2024, in addition to various meetings in the sub-groups online and in-person. During the sessions, the Cluster members presented current activities and

discussed possible joint projects. The IAU has developed <u>Terms of Reference</u> for Cluster Members and issues upon request Cluster Certificates. The Cluster Activity Report 2023-24 can be found here.

# Responsible Futures International

After the first seven institutions kicked off the international pilot in October 2023, the <u>IAU-SOS UK Responsible Futures International Programme</u> has been engaging students and staff through online meetings and communication activities ('Spotlights'), working towards the institutional audits concluding the first programme cycle. The achievements of the pilot group will be presented at the IAU International Conference 2024.

Publication with UNESCO, ESD Net Engagement and UN High-Level Political Forum (HLPF)

### IAU leads on UNESCO ESD Publication

The IAU has been commissioned by UNESCO to develop a new publication on the Whole-Institution Approach (WIA)

in the context of Education for Sustainable Development (ESD). Through a consultation in the spring of 2024, the IAU Network provided input for the drafting process. In May 2024, the IAU facilitated a UNESCO Webinar on the WIA ESD, which also contributed to the consultation for this publication. The publication will be tested through action research and published in 2025.

### ESD for 2030 Global Network

The IAU is a partner in the <u>ESD for 2030 Network</u>, following the UNESCO GAP ESD, and launched at the <u>UNESCO World Conference on ESD</u> in 2021. The IAU supports the Berlin declaration and the ESD for 2030 Roadmap.

# UN High-Level Political Forum (HLPF) 2024

The IAU actively participated during the HLPF 2024 for the sixth consecutive year, providing information to its Members and mobilising higher education for SDGs. Highlights included an official side event with the University of Bergen and the International Science Council (ISC) ISC, titled "Empowering Communities: Innovations in Local Air Monitoring for Sustainable Development amidst Multiple Crises," the HESI Global Forum, and IAU partner SULITEST's side event presenting survey results on "Faculty Perception for Sustainability in HE". Representing the IAU, Principal Investigator Kerry Ryan Chance of the Habitable Air project spoke during the session "Science, technology and innovation: Triggering transformation and sustaining science-driven solutions" on the urgent issue of air pollution and how this impacts on climate change and public health. See here an overview of the IAU at the HLPF.

### Other events of importance for HESD included:

- SDG 14 Workshop at the University of Bergen: In February 2024, IAU Programme Officer for Sustainable Development Isabel Toman was invited by the University of Bergen to <a href="mailto:present IAU's HESD initiatives">present IAU's HESD initiatives</a> and take part in the discussions around the revision of the Biology Masters programme to align with Education for Sustainable Development (ESD) and the SDGs.
- IAU sessions at SDG Bergen conference: The first of these two sessions focused on "A Whole-Institution Approach for ESD and the SDGs" and was organised in collaboration with SOS UK. The second session asked the question "Which Transitions are Needed to Integrate SDGs in Higher Education?" and was co-organised with UiB and the SDG 14 subcluster.
- IASAS Summit: IAU Vice President Jouhaina Gherib delivered a keynote on "Universities and Sustainable Development: Lessons from a third mission in the spotlight" at the <u>IASAS Global Summit</u> in Korea in May 2024.
- ▶ Jean Monnet Network Conference: IAU Programme Officer for Sustainable Development Isabel Toman spoke on a panel

on Higher Education and the SDGs in late June 2024 at the <u>Jean Monnet Network Conference</u> organised by RMIT Australia. During this session, she presented the IAU's work in the context of the conference theme "Time is Running Out! Systemic, Disruptive Innovation to Achieve the SDGs."

■ IAU Members and partners participated at the <u>UN Summit of the Future (SOTF)</u> in September and contributed to a <u>Statement</u> by the Education and Academia Stakeholder Group.

# **Partnerships**

The IAU HESD work supports UNESCO initiatives, in particular the ESD initiatives, The Futures of Education and Higher Education initiatives. Furthermore, IAU works in synergy with partner networks to further enhance the work on HESD.

# Other HESD Projects in the period under review include:

- University World News: The IAU partners with UWN for the UWN SDG Hub, opening up stronger visibility to IAU and its members working on SD.
- UNESCO's Greening Education Partnership: As a partner, the IAU attends working group meetings and stays informed on UNESCO engagement for ESD and at COP, and was invited onto the board of theUNESCO IOC Ocean Decade NGO Task Group (SDG 14).
- ▶ Regional Centres of Expertise on ESD: IAU sits on the Ubuntu Committee of Peers and advises the RCE network. IAU Secretary General Hilligje van't Land attended the online RCE Meeting in Tokyo in December 2023.
- Sulitest and SDSN France: Hilligje van't Land is on the leadership council/advisory board and IAU in close contact with both.
- IAU is working with other partners in HESD including UNODC, UNU-RCE, Sulitest, SDSN,ACU, EAUC, Oikos, MECCE and the HESI (Higher Education Sustainability Initiative).

# **Digital Transformation Working Group**

The working group on digital transformation, composed of Administrative Board members and chaired by Mohd Hamdi Abd Shukor, former Vice-Chancellor of the University of Malaya, Malaysia, provided strategic guidance for the activities within the priority of Digital Transformation. This year saw the implementation of new initiatives and the relaunch of the institutional site visit programme. The main achievements are highlighted on these pages.

# 1) Normative function



### The IAU Policy Statement:

Transforming Higher Education in the Digital World for the Global Common Good, adopted during the IAU 16<sup>th</sup> General Conference in 2022, continues to be the guiding framework for the different actions and activities which are implemented by the IAU. It outlines essential values and principles that

must underpin digital transformation. The IAU continues to nurture a shared commitment to building a human-centred, ethical, inclusive and purpose-based digital transformation of higher education for the global common good.

# **Open Science Expert Group**







The Open Science Expert Group began working together in October 2023. The +20 members have met regularly over the past year to identify the key opportunities and challenges for universities in the transition to Open Science. Framed by the UNESCO Recommendation on Open Science, the Expert Group has developed a report that aims to to support university leadership in promoting and contributing to the transition towards Open Science at the institutional level. The Expert Group provides advice and recommendations in terms of how universities play an essential role in leading as well as shaping this transformation. It also identifies different tensions and issues at stake for universities and it uncovers how important it is to collaborate at the global level to ensure a fair and inclusive implementation of the Open Science principles.

# 2) Monitoring function

After several years of rapid digital transformation particularly accelerated by the COVID-19 pandemic, the IAU is pleased to have launched the second Global Survey on Digital Transformation of Higher Education to monitor the current state of play. The questionnaire was developed in collaboration with an International Advisory Committee.

The questions of the survey cover multiple themes that most higher education institutions around the world are confronted with:

- Leveraging Digital Developments: How can digital advancements be harnessed to enhance teaching and learning and meeting the changing expectations of students?
- Exploring Generative AI: How to explore the benefits of generative AI while limiting the risks?
- Embracing Open Science: Is Open Science a priority for the institution, and if so, how to implement it in practice?
- Ensuring Cybersecurity and Data Privacy: Are the necessary measures in place to ensure a safe online environment and protect the data privacy of both staff and students?

The aim of the survey is to assess how ongoing technological developments are contributing to broad transformations in higher education. Participation from higher education institutions worldwide is essential to ensure that we have ample data to monitor current trends both globally and across the different world regions. The data collection is open until 1 December 2024 and the publication is foreseen towards the end of 2025.

# 3) Capacity Building and Peer-to-Peer Learning

# **Institutional Site Visits**

The IAU was pleased to relaunch the Institutional Site Visit programme this year. The programme aims to foster sharing of knowledge and experience among Members and to allow participants to acquire new insights on how to leverage the digital transformation in higher education.

This year the IAU met at Utrecht University, the Netherlands to discuss Open Science. The IAU brought together a group of 25

participants who joined the two-day meeting. Utrecht University organised an extraordinary lineup of staff from different parts of the university to share their experiences in the implementation of Open Science principles across the institution: from the important role of the library, to data stewards supporting staff with the necessary tools and information, it included examples of transformation towards Open Education and Community Engagement in science. The Site Visit moreover demonstrated the importance of reconsidering the structure of positions, including the rewards and recognition schemes and how metrics and rankings can be counterproductive to Open Science aspirations which in the case of Utrecht University led to a decision to withdraw from the THE Ranking.

The two-day programme enabled participants to gain insights into the impressive transformation that Utrecht University has undertaken over the past years to embrace the principles of Open Science leading to stimulating conversations among participants. The experience at Utrecht University showcased to what extent that commitment and engagement from all levels of the institution is crucial across the different faculties. Bringing together and recognizing the important contributions of staff regardless of function or status and rewarding them for their contributions to the global vision set out for the institution is key to support the shift in organisational culture.

# Universities and the Interplay of Human Intelligence and Generative AI



The widespread distribution of generative AI has raised many questions for higher education institutions to address, spanning a wide spectrum of visions from utopian ideals to dystopian scenarios. To shed light on what is at stake for higher education, the IAU devoted the 'In Focus' section of its bi-annual magazine IAU Horizons to the topic: Universities and the Interplay

between Human Intelligence and Generative AI. While

generative AI has caused quite a stir, numerous authors remind us that this is a natural reaction when society is exposed to new technological advancements that inherently challenge established procedures and practices. In addition, these developments also bring another complex question to the forefront: what does it mean to be human? Throughout the selection of articles, there is a common trend to view the impact of AI from a dual perspective outlining the opportunities alongside the risks. Striking a nuanced and informed balance in the trade-off between these is the current quest for higher education. In the same manner, many authors also remind us that human steering of generative AI becomes essential to proactively design how to use the technology to serve humanity.

In addition to the magazine, the IAU International Conferences remain a space where IAU fosters debate on how Generative AI is impacting universities. The IAU will continue to foster debate and dialogue around the potential opportunities and adverse effects of AI in higher education by bringing together voices from all regions of the world to raise awareness as well as generate mutual understanding of potential benefits and obstacles in different parts of the world.

# 4) Advocacy

The IAU continues to participate in events to present on digital transformation in higher education. Beyond presenting the data from the monitoring projects, it is also an opportunity to advocate for the principles and values outlined in the IAU Policy Statement.

# IAU Webinar Series

# 1 October 2023 to 30 September 2024

Throughout the past year, the IAU continued its <u>Webinar Series</u>: The Future of Higher Education. This webinar series, first developed in 2020, has grown to include over 70 webinars. This year's topics ranged from universities' role in society in fostering democracy, women in university leadership, the trends and future of internationalization,

to education for sustainable development. This year, the Association produced **9 webinars** which welcomed **58 speakers** from around the world. The IAU extends thanks to its many partners for the collaborative webinars produced this year: the Council of Europe, the European Women Rector's Association (EWORA), the Boston College

# Discover the latest webinars:

# Knowledge Diplomacy in a Changing World (24 October 2023)

This webinar was jointly presented by the IAU and the Centre for the Study of Higher Education (CSHE) at University College Dublin (UCD). In the past, science and cultural diplomacy were seen as an important contribution of universities. Now, the focus is shifting to knowledge diplomacy, emphasising education, research, and innovation. This webinar discussed how the development of relationships with diverse groups outside of the university has become increasingly important.

# MCO - IAU Webinar on Engagement with Civil Society - Experience from Latin America (6 December 2023)

The 'university extension' movement is currently undergoing a revival that is contributing to the democratic mission of the university. It takes different forms and has different names - extension, engagement, linkages, solidarity service learning, participatory action research, social responsibility, etc - but, they all share a common purpose, namely, to place the traditional teaching and research functions of the university within the overall context of the community and society in which it operates. With first-hand perspectives from Latin American countries, the webinar aims to showcase how the university can engage with local communities.

# IAU-UOC Webinar: The Mental Health Crisis -Building Resilience in a Changing World (16 Nov 2023)

Despite the WHO's announcement that the COVID-19 pandemic was no longer a public emergency in May 2023, many challenges persist, including the increase in mental health issues. Current health systems are having trouble matching the increase in demand related to mental health. Due to this, the IAU HESD Cluster on SDG 3: Good Health and Wellbeing has decided to focus on mental health within the higher education community. Experts from the Cluster discussed emerging trends on mental health across countries, lessons learned on how to support communities in uncertainty, new digital solutions, and the role that higher education and research play in the deployment of digital health tools.

# Global Cooperation Webinar on Higher education leadership for democracy, sustainability and social justice (25 January 2024)

This webinar launched the book "Higher Education Leadership for Democracy, Sustainability, and Social Justice" published by the Council of Europe as the 26<sup>th</sup> volume of its Higher Education Series. Several authors of the book were invited to share their viewpoints and discuss the need for higher education to influence and lead society to reinforce democracy, reverse extreme inequities, and build sustainability.

# IAU-EWORA: Tackling the Leaky Pipeline In Academic Leadership (5 March 2024)

In honour of International Women's Day 2024, the IAU and EWORA discussed the persisting challenges to gender equality in academic institutions, including invisible barriers that prevent women from progressing to senior positions. University leaders have the responsibility to implement policies that encourage and support staff in their professional development. Speakers included university leaders and experts in the field, who presented examples of good practice and shared their perspectives.

Center of International Higher Education (CIHE), the Asia-Pacific Association for International Education (APAIE), Qatar University, the eHealth Center at the Open University of Catalonia (UOC), and Universities4GoodHealth. # IAU Global Survey on Internationalization of Higher Education: Current Trends and Future Scenarios (2 April 2024)

This webinar launched the publication of the 6<sup>th</sup> edition of the IAU Global Survey on the Internationalization of Higher Education. This edition received responses from 722 higher education institutions (HEIs) in 110 countries and territories. The report analyses the findings in order to present both global and regional trends. Furthermore, it compares current findings with data from the IAU's previous Global Surveys on Internationalization in order to explore long-term changes occurring in the internationalization field.

# IAU-CIHE: Virtual Internationalization: Global, Regional, and National Perspectives on Virtual Exchange and COIL (17 April 2024)

This webinar brought together practices and debates on the emergent concept of virtual internationalization. Having left behind the assumption of virtual delivery as an emergency adaptation, virtual approaches to internationalization have emerged as innovations that complement other approaches. While many practices and approaches, such as Collaborative Online International Learning (COIL) and Virtual Exchange, have flourished recently, this webinar brought forth a dialogue of global, regional, and national perspectives.

# Internationalization of Higher Education in Asia & the Pacific: Current Trends and Future Scenarios (27 June 2024)

The Asia-Pacific region is incredibly diverse, with a vast array of cultures and education systems. To capture these varied perspectives, this webinar, co-organised with the Asia-Pacific Association for International Education (APAIE), explored internationalization trends in Asia Pacific, drawing insights from the results of the 6th IAU Global Survey on internationalization. Experts from key countries in the region discussed these findings, providing a comprehensive overview of the current state and future directions of internationalization of higher education across Asia and the Pacific.

# IAU & Qatar University: Internationalization of Higher Education in the MENA Region: Current Trends and Future Scenarios (3 September 2024)

The Middle East and North Africa (MENA) region is very heterogeneous, both in terms of the socio-economic status and political stability of the region's countries. This diversity impacts the quality of each countries' higher education sector and its internationalization policies. To reflect on these contrasting perspectives, this webinar investigated internationalization in the MENA region. The webinar, co-organised with Qatar University, welcomed experts from major countries in the region to discuss relevant trends for the region emerging from the results of the  $6^{th}$  IAU Global Survey on internationalization.

issues were published in the 2023-2024 financial year (36.4, 37.1, 37.2, 37.3). The latest issue (37.3) contains articles on various institutional policies, industrial and North-South partnerships, the lasting effects of COVID-19, support mechanisms, and academic career mobility.

The IAU HESD Global Portal is a tool developed by the IAU for its Members, partners, and the general public. First created in 2012 and launched at the IAU 14th General Conference in Puerto Rico, it was relaunched with additional features at the IAU 2023 International Conference in Qatar. This version features new functionality and an improved layout. The IAU HESD Portal constantly improves and integrates content submitted by IAU Members and partners and collected via desk-based research. Members and partners are invited to contribute relevant content to the network. While some services are offered on a priority basis for IAU members, the portal is openly accessible online. # World Higher Education Database (WHED)

The IAU has been collecting and publishing data on higher education systems and institutions around the world since its inception in 1950. This data is currently published via the World Higher Education Database (WHED). The portal is freely available to all and provides information on the education systems of 196 countries and territories as well as on 21,422 institutions. You can see the breakdown by region below:

The updating cycle for Africa is currently underway and is due to be completed for the first half of 2025. Current statistics show that just under 60% of institutions are privately funded, which is slightly more than the global average of 57%. It should be noted that these are preliminary figures and the IAU will have a clearer





picture of institutional funding, as well as other indicators, once the updating cycle is finished.

The WHED portal continues to include a unique identifier (the Global WHED ID) for each institution listed. These identifiers are being increasingly integrated into internal information systems and have become a vital tool in international higher education surveying and they have been used by various IAU partners and HE stakeholders. A new development this year is the deployment of permalinks for each institution listed in the WHED – these can be used in institutional communications and they make for easy identification of institutions in the WHED.

The IAU continues to provide data extractions, and these are frequently being used for research and by institutions to create student admission and HR onboarding systems.






